# SECTION 1.

## Overview of the drug problem in Dublin North East Local DATF

### Introduction

The Dublin North East Local Drug & Alcohol Task Force has had a very challenging year. Its progress has been seriously impacted by a long period of illness in management and a number of changes in membership including its chairperson and location of the core offices.

Despite these challenges, the DNE LDATF led by a strong team of directors and chairperson, has begun an intensive review strategy to support important service improvements. This has included but is not limited to

- Expansion of services to provide a more targeted approach in high priority areas including Bonnybrook
- Engagement in the Integrated Alcohol Service at community level in Darndale
- Establishment of a small grants scheme for Aftercare and Recovery Initiatives
- Funding of new play therapist post to address hidden harm experienced by children.
- Establishment of Family Support Coordinator to implement evidence informed interventions for people impacted by familial substance use.
- External and independent 'listening' process commissioned to capture perceptions about the role of the DNE LDATF in the community and inform improvements to make it more effective and relevant in line with national NDS priorities.
- Engagement with the Nth Dublin RDATEF SUPPORT initiative for service user engagement and imbedding engagement strategies into local services to inform service improvements based on the lived experience of people who use them.

In this context, the DNE LDATF is in very good shape to enhance the services being provided and engage more meaningfully with the community, service providers and clients and families it services

## DRUG TRENDS IN DUBLIN NORTH EAST LOCAL DATF AREA

The central treatment list is an administrative database to regulate the dispensing of methadone treatment. The Central Treatment List (CTL) was established under Statutory Instrument No. 225 (Minister for Health and Children 1998) and is a complete register of all patients receiving methadone (as treatment for problems with piat use) in Ireland. When a person is considered suitable for methadone detoxification, stabilisation

or maintenance, a unique number is allocated to the client and a treatment card is issued for clients when dispensed in community pharmacies.

The data is not broken down into specific task force areas however it does highlight that CHO-9 (North Dublin City and County) has the highest number of people receiving OST.


# HRB NATIONAL DRUG TREATMENT DATA FOR DUBLIN NORTH EAST LOCAL DATF

The HRB provides a central data collection system for all drug and alcohol treatment services funded by the exchequer.

When service users attend for treatment their assessment data is captured on a data collection form called the NDTRS which is submitted to the Health Research Board. The composite data is sent back to each task force coordinator in the country (10 regional and 14 local) to collate and disseminate to task force members and stakeholders to inform strategy development and service planning. The limitations of the data is that it only captures new treated cases and not prevalence however it does give a good indicator of drug trends and changes in service user profile. This section of the report captures a high level analysis of some of the trends from the analysis of the treatment data from full year 2022 for people who sought treatment and live in North East Local Drug Task Force area.

## Reason for Referral new drug and alcohol treated cases living in DNE area in 2022


In total there were 800 new treated episodes in 2022. Indications are that most services are compliant with the NDTRS process however it would be expected to see higher numbers accessing treatment in the DNE area with its make up of services and high levels of disadvantage. It should be noted that this data refers to people who live in the DNE area and were treated. It is possible that the number of cases treated by services is higher based on referrals from people living outside the catchment area. There were high number of family members who received support as captured in the 'concerned person' data. Again these were not necessarily treated within services in the DNE area but were family members who live in the area. It is expected that numbers for alcohol specific treatment will rise as the area has services involved in CHO-9 integrated alcohol service.



## Primary drug presentation in new treated cases living in DNE area in 2022

Similar to other DATF areas around the country, when the 'drug' category is broken down into specific drugs it is clear that cocaine is a significant problem in the area and is the most prominent primary drug presentation. To address this the DNE areas drug projects engaged in cocaine specific programmes.

### Reason for Referral by Individual Drug 2022




### Source of referral for new treated cases residing in DNE area in 2022

It is useful to see where referrals to treatment are coming from. In the case of DNE there are high levels of self referrals. This is not unusual and is often an interpretation issue. If a formal referral form has not been completed by a referring service but they have given information to a person to access a treatment service this will usually not be classed as an agency referral but as a 'self' referral.

There are some surprising stats in this data set for eg: lack of referrals from justice agencies. This was discussed in a task force meeting 7.9.23 and it was thought it may be an interpretation on the data collection form. Training the new HRB forms is being organized to address this

### Referral Source New Treated Cases Living in DNE LDATF 2022




## Gender breakdown for new treated cases living in the DNE area in 2022

Typically men tend to find it easier to access treatment than women and there is robust research to illustrate the barriers that cause women to delay accessing support when needed not least; stigma, fear of TUSLA involvement with children, domestic violence, trauma and other issues. The DNE data shows that while there is certainly a higher percentage of men featuring in new cases the gap for access between the genders is not as great as some areas. The NDTRS has restrictions around reporting for data protection reasons and so will not report on numbers less than 5.

Non binary is a category in the NDTRS but does not feature in this data set most likely due to this restriction.


### New Treated Cases Living in DNE LDATF by Gender 2022




## Employment status of new treated cases for drugs/alcohol living in the DNE area in 2022

There is robust evidence that recovery capital is an essential component of sustainable recovery journeys for people who use drugs/alcohol. Structure, purpose and the opportunity to engage in life in the mainstream including employment and education is an important aspect of recovery capital.

The high levels of unemployment compared to national averages of people who sought treatment presents a rationale for engaging with adult education and labour market intervention organizations including SICAP implementers.



### Age Profile of New Treated Cases Living in the DNE LDATF Area 2022




### Family systems and wider support needs of new treated cases for drugs/alcohol living in DNE area

### New Treated Cases Living in DNE LDATF by Living Arrangements 2022




## Hidden harm and children for treated cases living in DNE area in 2022


There is a longstanding recognition that problematic parental substance use can increase trauma and other hidden harm for children. The DNE has a cohort of people who sought treatment in 2022 for drug/alcohol use who have children and

some with very young children. To meet the needs of children and the family system including improving parental capacity it is important that the DNE develops a coordinated approach to family support

### New Treated Cases Living in DNE LDATF with Children under 5 2022




## Housing status of new treated cases for people living in DNE area in 2022

In terms of recovery capital stable housing is a key element. The lack of secure accommodation is recognized as a very unstabilising when trying to access treatment and maintain recovery. The data

for DNE is encouraging in this regard with stable accommodation a feature of most peoples housing status who accessed drug and alcohol treatment in 2022.


### Home Status New Treated Cases Living in the DNE LDATF Area 2022



## Poly drug use for new treated cases for people living in DNE area in 2022

Analysis of the 2022 treatment data shows that roughly a third of all treated cases had problems with more than one drug no assessment. This means people presented seeking support for specific drug and on further exploration additional drugs were identified that were also impacting negatively on their quality of life.

### More than one Drug Presenting Problem New Treated Cases Living in the DNE Area 2022




## Severity of alcohol problem for treated cases for alcohol in 2022 living in DNE area

Alcohol was added to the remit of task forces in 2013. This was a particular challenge for local DATFS where most existing services had been established to provide treatment options to address opiate use which was historically prevalent. This presents issues in relation to capacity building for services and perceptions about the role of drug services in communities. Given these challenges, it is not surprising that

alcohol treatment presentations are relatively low for the area. Of those who did present, there are more people who are alcohol dependent than any other category of severity. With the rollout of SAOR training and increased focus on MECC in primary care it is hoped more people will access support sooner in line with slaintecare and Health and wellbeing priorities.

<b>Hazardous Drinking</b>	Drinking over recommended weekly limit -17 men and 11 for women. also binge drinking (more than 6 std drinks in one go).
<b>Harmful Drinking</b>	Drinking over recommended weekly limited and experiencing health problems directly related to alcohol.
<b>Dependent Drinking</b>	Dependent means that a person feels that they are unable to function without alcohol and the consumption of alcohol becomes an important - or sometimes the most important - factor in their life. May also experience withdrawals if suddenly stopping.

The DNE is engaged in the CHO-9 Integrated Alcohol Service so it is expected that there will be an increase in referrals in this regard.

## MAIN ISSUES WHICH THE DNE LDATF ADDRESSED IN 2022 ARISING FROM PATTERNS OF DRUG USE

It is clear from the treatment data that alcohol and cocaine are significant problems in the DNE area. Historically, drug services in the area have been focused on opiate use as was the case for most DATFS on foot of the 'Rabbitte report' in the nineties.

To address the changing drug landscape in the area and the increase in cocaine use, the Dept of Health, DPU funding distributed via the HSE CHO-9 was used by services in DNE to deliver cocaine specific groups. These were delivered in 10-12 week programmes and available to anyone in living in the area even if not already connected with services. The DYP and EDIT projects in the DNE area collaborated to deliver powder cocaine programmes to address this need.

Furthermore, the DALES project in the Darndale area was the named psychosocial service in the DNE area to partners with the HSE CHO-9 Integrated Alcohol Service and is an active member of the steering group. While it will take some time and capacity building to address the need for dedicated alcohol service provision in the area, there is a concerted focus on addressing this gap. The data reveals a real concern in relation to Hidden Harm and impact of substance use on children particularly.

While there are excellent projects in the area including Preparing for Life, the DNE LDATF recognized the need for further targeted supports. It funded a play therapist for children impacted by familial drug use in 2022/2023.

Furthermore, in recognition of the need for more targeted family support and a strategic approach to same it established an area wide family support role currently hosted in the KCCP project in Kilbarrack but serving the whole area. This will see 5step and other evidence informed interventions delivered in the DNE area.

The need for aftercare to support people with attaining and maintaining recovery was also identified along with the need for a very visible recovery community to reduce stigma. The DNE LDATF rolled out its Aftercare and Recovery fund to support this and invited EOIs from all projects in the area. There was a good uptake in this and plans to enhance this further in the future to ensure it is targeted at those who need it most.

To address the need for targeted supports in the DNE, the DYP was commissioned through an open tendering process to expand frontline service into the Bonnybrook area.

## COLLECTIVE PROGRESS IN IMPLEMENTING RESPONSE TO DRUG AND ALCOHOL RELATED HARM IN DNE LOCAL DATF

The DNE area has a large population and high levels of disadvantage which creates a challenge. However, it also has a range of community based projects and other linked social inclusion services.

The last year saw an increase in collaborative working and a refocussing of the DNE Task Force on coordinated care.

Notable collaborations between services included (1)Integrated Alcohol Service with CHO-9HSE addiction service and DALES project in Darndale (2)DYP and EDIT partnership to deliver cocaine programmes (3)KCCP hosting the Family Support Coordinator (4)establishment of play therapist to support referrals from all services (4)Establishment of Aftercare & recovery activities programme which was accessed by multiple partners (5)calendar of events and activities for Recovery Month across services.

Furthermore, the DNE through an independent consultation process has plans to establish a continuum of care network to bring all relevant frontline services in the area together to agree a seamless continuum of care for people who use drugs/alcohol and their families.

The focus will be on coordinated transition from early engagement to aftercare and recovery including family support. Membership will include but not be limited to: frontline treatment & rehabilitation services, Family Support, Probation, Preparing for Life, HSE addiction services and others.

## PROGRESS REPORT IN RELATION TO ACTION 4.2.44 OF THE NATIONAL DRUG STRATEGY IN RELATION TO SERVICE USER ENGAGEMENT

The DNE LDATF has a long history of service user engagement and in particular service user for a development. This has been difficult to maintain with staff changes and no standardised framework in place. The DNE LDATF recently engaged with the SUPPORT initiative of the North Dublin RDATEF within CHO-9.

Following an information presentation to the management committee of the DNE LDATF, the DNE LDATF continues to engage with the SUPPORT initiative and has plans to develop a taskforce wide coordinated strategy which will include the following

- Establishment of service user reps in each of the funded services
- Using the SUPPORT service user guidelines for a guide
- Delivery of a number of surveys with users of drug and family support services
- Coproduction groups with users of drug and family support services to inform service improvements
- Establishment of an expert by experience network
